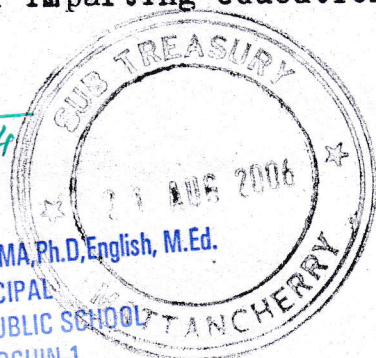

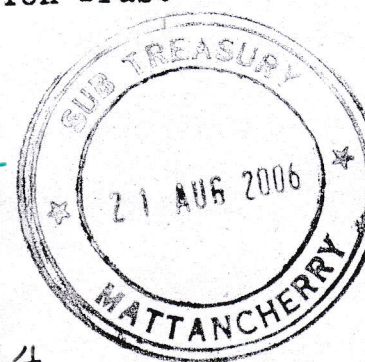

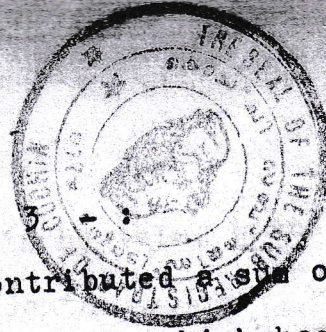

02. That the Author has already contributed a sum of Rs.1,000/- (rupees one thousand only) for the nucleus fund, which has been paid, transferred and handed over to the persons mentioned and described hereunder who have consented to be and are appointed as the Trustees to constitute the Board of Trustees on this the 21-10-2002.

03. The office of the Trust shall be at Bishop's House, Fort Cochin, Cochin-682 001 having Door No:C.C.XI/807 or such other place or places as the Trustees may decide from time to time.

04. The objectives of the trust shall be:-

04.1. To establish and maintain Public schools, Professional and other Colleges, Polytechnics, Industrial training Institutions for the promotion of education among the public in general and Cochin area in particular.

04.2. To establish and maintain institutions intended for educational and cultural advancement of the public and their social welfare and physical well being.

04.3. To conduct coaching classes for all competitive examinations, entrance examinations for professional and other, course and conductive examinations for employment in Public and Private sector.

04.4. To conduct classes for students in fine arts like dance, music, painting etc.,

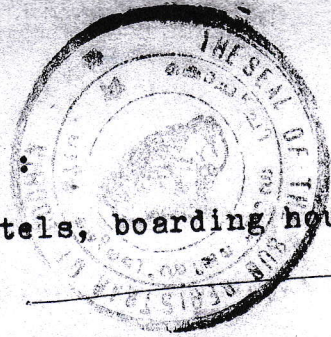
04.5. To offer studies in all management and linguistic and job oriented areas.

04.6. To organize conducted tours, with educative values to places of national importance.

04.17. To hold conferences, seminars and work shops on issues of public interest.

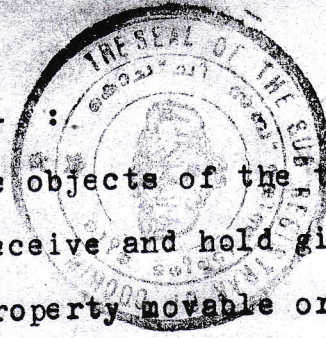
04.18. To co-operate with and contribute to the funds of other similar institutions or individuals, governmental or private agencies carrying out any or all objects of the Trust.

04.19. To accept donations, grants, endowments, presents and other offerings in cash or in kind from individuals from institutions, private and public Trusts, Governments and to deal with such donations for the purpose of the Trust in appropriate manner.

04.20. To undertake, establish, sponsor, promote, accept and act as custodians and hold property of all kinds the income, which is

04.22. To do all such other lawful acts or deeds as are essential to attainment the objects of the Trust.

04.23. To help and assist the poor and needy sections of the society by providing free/subsidized education, vocational training, technical training etc.,

04.24. To strive for ever all development of the poor and needy sections of the society, particularly women and children and to plan execute and manage programmes for their upliftment.

04.25. To provide manpower and assistance and join hands with government and other agencies to prevent environmental pollution, to maintain ecological and encironmental balance and to preserve natural resources in villages.

04.26. To establish training centers for skills development and capacity building.

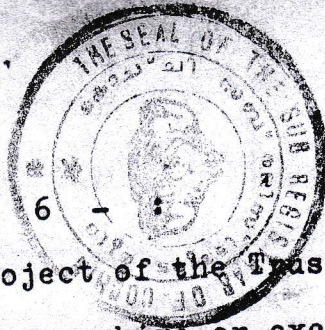

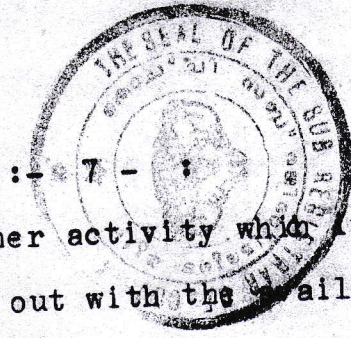
04.30. To sell, transfer, or dispose of the whole or any part of the business or activity or undertaking of the Trust to any other Trust, company, person, firm or corporation for such consideration as the Trust may deem fit.

04.31. To borrow or raise money in such manner as the Trust shall think fit and furnish as security for any such money soborrowed, raised or owing, mortgage, pledge or charge, the whole or any part of the property, assets or revenue of the Trust, present or future, by special assignment or otherwise and to redeem, to pay off any such securities.

04.32. To enter into any agreement with any Government or authority supreme, municipal, local, or otherwise that may seem conducive to the Trust's objects or any of them and to obtain from any such Government or authority, any rights, concessions, grants and privileges which the Trust may think it desirable to obtain and to carry out, exercise and comply with any such arrangements, rights, privileges, grants and concessions.

04.34. To award scholarships, prizes, medals, stipends, educational aids and loans to deserving students or any other persons or class or persons.

04.35. To take over any trust or society with similar objects.

04.36. To engage any activity which will be conducive to the attainment of the objects of the Trust.

04.37. To objects of the Trust should be attained without any motives of profit making.

04.38. To collect funds by way of subscriptions, donations and by the conduct of Kuries, grants, loans and other contribution from members, government, cooperative bodies and individual and funding agencies for general as well as specific purpose, and performance support the activities of the Trust-----AUTHOR--Bishop John Thatt (SD)----5.

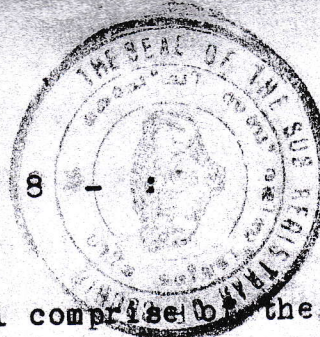
05. For removal of doubts, it is hereby clarified that the object will be presented in such a way as to benefit all people without distinction of religion, race, creed or social status.

06. The Trust fund may be augmented by donations and other contributions from time to time.

07. The fund of the Trust shall not be applied for any purpose other than the object of the trust stated in para 3 above.

08. The founder has this day contributed in all a sum of Rs.10 (rupees one thousand only) towards the Trust Fund, which shall be

09. The Trust property shall comprise the said initial Trust Fund as well as other amounts, securities, properties movable or immovable which may be contributed or donated by first Trustees, Members of the Public or from any other source and shall also include all additions accretions made by the Trust and the income received by the Trust from time to time Trust property shall vest in the Trustees, subject to the provisions hereof for the due fulfilment of the objects of the Trust.

10. This Trust shall be administered by a Board of Trustees whose number shall not be less than three or more than ten and chaired by the Author of the Trust.

The Trustee shall elect the Treasurer and Secretary from among themselves once in 3 years or every three year from the meeting of the Trustees, maintaining minutes accounts records and other documents of Trust shall be looked after by the Secretary. The Treasurer shall be in charge of the funds of the Trust. The Board of Trustees is empowered to give independent charge of each function division to one Trustee.

First Trustees are.

1. Msgr. Joseph Karyil, Vicar General of Cochin Diocese, aged 53 (fiftythree) years, priest, son of Kunjuvareed, residing at Bishop's House, Fort Cochin Desom and Village, Kochi Taluk.

2. Fr. Thomas Parathara, Chancellor of the Diocese of Cochin, aged 55(fiftyfive) years, son of Rocky Parathara, residing at Bishop's House, Fort Cochin Desom and Village, Kochi Taluk.

3. Fr. Josey Kandanttuthara, General Manager, Corporate Education Agency of the Diocese of Cochin, aged 47 (fortyseven) years, priest Son of George Kandanttuthara, residing at Catholic Centre, Thoppump

4. Fr. Joppy Kootumkal, Procurator of Cochin Diocese, aged 47 (fortyseven) years, priest, son of Joseph, residing at Bishop's House Fort Cochin Desom and Village, Kochi Taluk.

5. Fr. John Kandathiparambil, Director E-Land, aged 35 (thirtyfive) years, priest, son of Joseph, residing at Cochin E-Land, Perumpadappu, Cochin-682 006-----AUTHOR. Bishop John Thattumkal(SD)-----6-----

11. A Trustee shall cease to be in office with immediate effect on the becoming insolvent or insane or on being convicted for any offences involving moral turpitude or when the person becomes incapable of following the objects of the Trust or when the person is removed from the specific diocesan office attached to him. Any vacancy occurring in the office of the Trustees shall be filled by appointment of the special diocesan office.

12. The Trustees may from time to time delegate to any one of them or to any other person or Committee, such of their powers and duties, as they deem fit, subject to their retaining the ultimate control and supervision.

13. The Trustees should meet as often as necessary provided at least one meeting is held in every 3 months. The quorum shall be the presence of at least 3 Trustees. All decisions of the Trust, unless expressly provided otherwise, shall be by simple majority. The Chairman of the meeting shall be entitled to a casting vote in the event of equality of votes at the meeting.

14. The term of office of nominated or co-opted Trustee shall be 3 years. Therefore, they will be eligible for reappointment by 2/3 majority of the Board.

15. Any Trustees can be removed from the office before the expiry of their term if their views, activities and life are against the ideals

of the Trust and are thus prejudicial to its interests. Such removal should be by a 2/3rd majority of the Board of Trustees.

16. The Trustees shall maintain true and correct accounts of all receipts and payments and dealing in regard to the trust property and shall also maintain a correct record of their meetings and deliberations.

17. Bank account/s may be opened for the Trust in such bank as the Board of Trustees decides from time to time. The Bank account shall be operated jointly by the managing and joint managing Trustee.

18. The Trustees shall have and may exercise all such powers, as in their opinion, shall enable them to effectively carry out all or any of the trust purposes without prejudice to the generality of the foregoing the trustees shall have the power.

18.1. To raise additional funds for augmenting the corpus of the Trust fund by accepting contributions and through appropriating programmes to support the Trust objects such programmes and schemes may recognize different donor status and may also differentiate between individual and institutional donors.

18.2. To purchase, hire, take on lease or invest the corpus of the trust fund or any part thereof in lands and movable, and immovable properties.

18.3. To borrow monies on such terms and conditions as the Trustees consider necessary or desirable.-----AUTHOR-Bishop John Thattumkal(SD)-----7-----

18.4. To sell, mortgage, change, lease, hire the Trust investments.

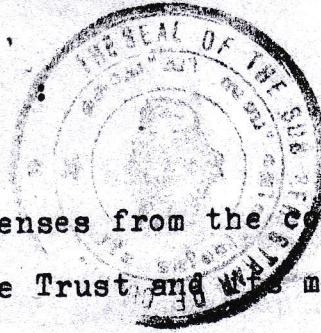
18.5. To accept gifts in kind or in cash.

18.6. To employ persons, professionals' organizations consultants and agencies to assist the Trustee to carry out the Trust purposes and to terminate suspend or cancel such appointment or engagements.

18.7. To institute, prosecute and defend all suits and other legal proceedings and to appeal and act before courts, tribunals and public

18.8. To incur all necessary expenses from the corpus of income of the Trust in connection with the Trust and its management and for its institutions.

19. The Surpluses fund of the trust shall be invested in the modes prescribed under section 13(1) (d) read with section 11 (5) of the Income Tax Act 1961 as amended from time to time.

10. The Trust shall follow financial year as its accounting year; the account of each year shall be audited by a chartered accountant or a firm of chartered accounts who shall be appointed by the Trustees

21. Any of the terms of this deed including the trust purposes may be varied, extended or amended from time to time by an instrument in writing under the hand of the Trustees, to be approved by them at a meeting convened for that specific purpose Provided however that.

21.1. Such amendments should have the prior permission from the commissioner of Income Tax, Ernakulam.

21.2. It should not be contrary to or inconsistent with the trust purpose.

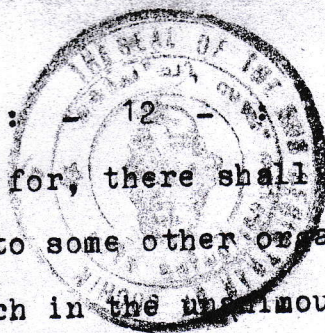
21.3. The approval by the Trustee should be in a duly convened meeting with at least 2/3rd of the Trustees present agreeing for the amendment.

22. For the proper conduct of the affairs of the Trust its administration and management of funds and accounts the Trustees shall have to frame and implement rules and regulations which shall be consistent with presents herein provided.

23. The Trust formed is irrevocable.

24. If the Trustees are unanimously of the opinion that the trust be dissolved such dissolution shall be effected by an instrument in writing under their hand and if all debts and liabilities of the Trust

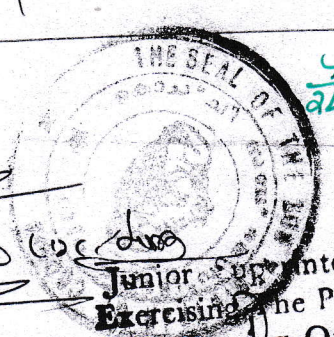
